This document states the terms and conditions governing the use of the web www.campinglasdunas.com (hereinafter The Web) in accordance with the provisions of Law 34/2002 of Services of the Information Society and Electronic Commerce.

This website and its domain belong to Camping Les Dunes S.A. (hereafter Camping Las Dunas), registered in the Mercantile Register of Girona, volume 491, book 0, page 18, section 8, sheet GI9531, inscription 10 from 24th March of 2003.

Privacy Policy

In compliance with the Organic Law 15/1999 of 13th December on the Protection of Personal Data Camping Las Dunas informs that:

Identification and personal data provided by the user within the framework of the present web site, provided via form or via e-mail, are confidential and will be part of the computerized files owned by Camping Las Dunas, which will be the only recipient and holder of such data.

These files contain the essential information required to provide the products and services offered through The Web or to attend the consultations of users. They may also be used for statistical analysis and to comply with the requirements of accounting, billing and auditing of Camping Las Dunas.

Users expressly authorize Camping Las Dunas to send them commercial information about their products and services. Users may revoke their authorization at any time by notifying it via e-mail, fax or regular mail.

Camping Las Dunas, being responsible for these files, commits to comply with the obligation of privacy regarding their content.
